9. An additional fee of \$31 will be charged for any returned checks.
10. Vendors must remove all items at the end of the yard sale or will be charged an additional \$50 fee.
11. Vendors must clear the grounds by 4:00 p.m. the day of the sale.
12. NO PETS ARE ALLOWED ON THE GROUNDS THE DAY OF THE SALE.
13. The Mount Airy Lions Club is not responsible for accidents or loss of property.
14. The Mount Airy Lions Club reserves the right to refuse admission or eject any vendor or buyer.
