- 12 An additional fee of \$31 will be charged for returned checks.
- 13 Vendors must remove ALL items at the end of the event or will be charged \$50
- 14 Vendors must clear the grounds by 4:00pm the day of the sale.
- 15 Vendors will not begin setup until after 7pm on the Friday night before the event.
- 16 NO PETS ARE ALLOWED ON THE GROUNDS THE DAY OF THE SALE
- 17 The Mt Airy Lions Club is not responsible for accidents or loss of property
- 18 The Mt Airy Lions Club reserves the right to refuse admission or eject any vendor or buyer.
